A. PRICE AND PAYMENT TERMS

1) PRICE, ETC.:

PRICES: Prices represent payment by check or money transfer (see “Payment Details” below). Credit card payments incur an additional 3.5% credit card fee (waived for the initial \$300 deposit). For information on possible ways of transferring money see “Payment Details” below.

PRICE: Tour price without air travel is \$3950 (double occupancy). Single Occupancy if available \$1100 additional.

TOUR PRICE includes:

- 9 Nights lodging (double occupancy) with private bath. All our accommodations are in religious pilgrimage houses walking distance from Major Shrines (Nazareth, Sea of Galilee, Old City in Jerusalem)
- Breakfast and Dinner each day.
- Private Motor Coach (A/C, Wi-Fi, etc.), guides, entrance fees, etc.
- Accompaniment of a Traditional Latin Mass Catholic Priest

Price does not include AIR TRAVEL, lunches, beverages with meals, personal expenses, or tips for guide, driver, and accommodations. (\$120 per person will be collected for those tips). Ask about any other concerns.

4) PAYMENT DETAILS AND SCHEDULE

Payment Details:

- Checks in US Dollars drawn on US banks (only) should be made out to **“Dominus Flevit”** and sent to Roy Schoeman, 4730 Navassa Lane, Naples, FL 34119.
- For other means of payment, such as bank transfer, Venmo or Zelle, Wise, etc. contact Roy.
- Bank transfer and/or currency conversion fees are the responsibility of the traveler.

How to Register:

- Read this document
- Fill out and send in the registration form page and signature page
- DO NOT send deposit until informed of availability.

Payment Schedule:

- \$300 deposit per traveler is required upon registration. (fully refundable for 21 days).
- \$1500 Payment is due November 1.
- Remaining balance is due March 1

Cancellations/Refunds:

- Initial registration deposit is refundable for 21 days
- For travelers canceling prior to January 1, funds paid less \$1200 will be refunded
- For travelers canceling prior to April 1, funds paid less \$2000 will be refunded
- No refunds for travelers canceling after April 1.

Travel insurance is advised to protect against unforeseen circumstances requiring cancellation (see below section B.2).

IF THE TRIP ITSELF IS CANCELED, ALL FUNDS WILL BE RETURNED LESS \$300, WHICH CAN BE APPLIED TO A FUTURE PILGRIMAGE.

B.TERMS & CONDITIONS (includes Waiver of Liability and Binding Arbitration Clause)

1) CANCELLATION TERMS

See "Payment Details and Schedule" on this form for details on cancellation deadlines and penalties. Cancellations must be made in writing. From time to time government agencies issue travel advisories or warnings. Dominus Flevit is not obligated to cancel the program, nor change the cancellation terms and conditions, based on any such warning or advisory, or the occurrence of any act of terror, health, civil unrest, or other incidents in one or more of the places we are scheduled to go. Dominus Flevit reserves the right to change the itinerary or program features for any reason, and shall not be liable for any loss of any kind as a result of such changes. Dominus Flevit may cancel program for any reason whatsoever. In the case of such cancellation, its sole obligation is to issue refunds in the full amount of moneys paid to Dominus Flevit less \$300, which can be applied to future pilgrimages.

2) TRAVEL PROTECTION

Dominus Flevit recommends the purchase of travel insurance to help protect the traveler's investment in this trip, and to help provide medical coverage while traveling. Terms vary, read the conditions carefully. Traveler agrees that under no circumstance will Dominus Flevit refund the cost of purchased travel insurance. Some plan benefits are available only if the plan is purchased by a certain date after booking. Dominus Flevit does not offer or act as an intermediary in providing such insurance. *Websites such as squaremouth.com provide details on various plans from different insurers.*

3) IDENTIFICATION, PASSPORTS, AND VISAS

A passport valid for at least for six months following the return date of the trip is required. Please allow for sufficient processing time when applying for a passport. Expedited passport services are available at additional cost. Please provide a copy of the inside photo page of your passport with registration.

An Electronic Travel Authorization (ETA-IL) is required for travelers from the U.K. prior to visiting Israel. To obtain one, visit <https://israel-entry.piba.gov.il>. The current cost is about \$8.

Trip organizer is not responsible for denial of entry to Israel if passport is not valid for 6 months following the return date of the trip or if no ETA-IL is obtained.

Non-U.S. passport holders are responsible for researching and obtaining proper passports, visas, permits, and related documentation in order to travel.

4) ITINERARY

The itinerary is subject to change.

5) PARTICIPATION

Dominus Flevit reserves the right to decline any participant if, in its sole discretion, it deems their participation would be dangerous to themselves or disadvantageous to the pilgrimage. The minimum age for participation is 18 unless an explicit exception is granted prior to registration.

Pilgrims must be medically and physically fit for the tour. There will be substantial walking over uneven terrain, steps to climb, periods of standing, etc. Some of our pilgrimage houses may not make provision for diminished mobility. Please discuss any such concerns, as well as any dietary restrictions or concerns, with Roy prior to registration.

6) AIR TRAVEL AND TRANSPORTATION

LUGGAGE & PERSONAL PROPERTY

Luggage is the traveler's responsibility throughout the tour. Dominus Flevit is not responsible for the traveler's personal property while on the tour.

Checked Baggage: Each traveler is limited to one checked bag. For most airlines, checked bags are limited to 50 pounds and 62 inches (length+ width+ height). If these specifications are exceeded, additional charges may be collected by the airline at the airport. Please refer to the carrier for exact charges and baggage dimensions.

Carry-on Baggage: Please check the carry-on limitations with the airlines, and the TSA restrictions on what is allowed in carry-on baggage.

Our pilgrimage houses may not have portage service for baggage, requiring the pilgrim (or a fellow pilgrim volunteer) to carry his/her own bags.

FLIGHT CANCELLATIONS AND DELAYS: Dominus Flevit is not responsible for any loss incurred by travelers due to a canceled flight or other means of transportation. Travel protection plans may be available to cover such a loss. Outbound and return travel are the sole responsibility of the traveler.

7) BINDING ARBITRATION

The traveler agrees that any dispute concerning, relating or referring to this contract itself, shall be resolved exclusively by binding arbitration pursuant to the Comprehensive Arbitration Rules & Procedures of the Judicial Arbitration and Mediation Services, Inc. (JAMS). Such proceedings will take place in Naples, Florida. The arbitrator and not any federal, state, or local court or agency, shall have exclusive authority to resolve any dispute relating to this contract, including but not limited to, any claim that all or any part of this contract is void or voidable. Traveler understands that by agreeing to these terms and conditions, traveler and Dominus Flevit waive right to a trial by jury. Any arbitration commenced against Dominus Flevit must be on behalf of only the signatory to this Agreement and his or her immediate family members who travelled with signatory. Under no circumstances can a participant be part of a class or other joint action.

8) LIABILITY RELEASE

Dominus Flevit does not own or operate any entity which provides goods or services for your tour, including lodging facilities, transportation companies, local ground operators, including, without limitation, guides, sightseeing companies, food providers, etc. As a result, Dominus Flevit is not responsible for any negligent or willful act or failure to act of any such person or entity it does not own or control.

Without limitation, Dominus Flevit is not liable for any financial, physical or other direct, indirect, consequential, or incidental damage, injury, death, loss, accident, delay, inconvenience or irregularity of any kind including cancellation of trip or of air travel arrangement which may be occasioned by reason of any act or omission beyond its control, including, without limitation: any negligent or willful act, failure to act, breach of contract or violation of local law or regulation of any third party such as an airline, hotel, bus, taxi, van, restaurant, local ground handler or guide; delay or changes in schedule, overbooking of accommodation, default of any third party, attacks or bites by animals, insects or pests, injury or death while on activities; sickness, the lack of appropriate medical care, weather, labor activities or strikes, acts of God or government, acts of terrorism, or the threat thereof, force majeure, war, quarantine, pandemic, epidemic, or the threat thereof, criminal activity, or any other cause beyond its control. Unless the trip is canceled by Dominus Flevit prior to departure, Dominus Flevit's sole obligation is to issue refunds to the extent its suppliers refund Dominus Flevit the money paid to them by Dominus Flevit. If it is canceled before departure, its sole obligation is as described in Section B-1.
